

## Voting results Annual General Meeting of Randstad Holding nv held on 31 March 2016

According to the list of attendees a total of 865 shareholders attended the meeting representing a total of 213,734,652 shares with an entitlement to vote at the meeting (with and without proxies), of which 25,200,000 preference shares class B and 50,130,352 preference shares class C. They could cast a total number of 147,604,300 votes (76,85% of the total number of votes that may be cast), of which 3,600,000 on the preference shares B and 5,600,000 on the preference shares C.
